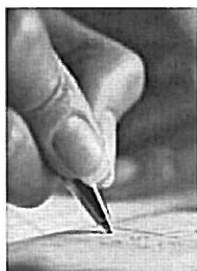

Extension Requests Are No Longer Required in Pennsylvania.

Eligible organizations automatically receive the full 180-day extension at the time registration is approved. If you were not in an approved status for any previous year, your organization is not eligible for any extension until it has fully complied with registration requirements and has been approved by the Bureau. As such, no extension requests will be reviewed by the Bureau.

Although Pennsylvania has amended its extension procedures, please recognize that this does not eliminate the need to follow established extension request procedures with the Internal Revenue Service.

Renewal Reminders will no longer be mailed.
