

PA Municipal Planning Code

 Provides a wide array of regulatory tools to aide in making the best decisions for the growth, development, and well-being of a community.

 Requires municipalities that do regulate land use to follow specific procedures and outline those procedures.

 Section 301 requires that a comprehensive plan be developed for: floodplain land use; floodplain management as it relates to community facilities and utilities; and protection of flood plains as a natural resource.

Comprehensive Planning

- 2,560 Municipalities in Pennsylvania
 - 58% of Municipalities have Comprehensive Plans
 - 68% of Municipalities Operate Under Zoning Ordinance
 - 94% of Municipalities Operate Under a SALDO Ordinance
- 67 Counties in Pennsylvania
- Multi-Municipal Comprehensive Planning for Floodplain Mitigation and Management





- Subdivision and Land Use Development
- Local Building Permits

Compliance Issues with NFIP

- Failure to Enforce Local Floodplain Regulations
- Program and Administrative Deficiencies
- An Individual Property is NOT in Compliance with Local Regulations

Consequences for Compliance Issues

- Community Rating System Retrograde
- Probation
- Suspension
- Subrogation Action Against the Community
- Community-wide Verification of Insurance Rates
- Recertification of each Flood Insurance Policy at Renewal

Municipal Assistance Program (MAP) Grant

MAP funding will be used to reimburse municipalities for costs incurred **in preparation**, **enactment**, **administration**, **and enforcement of floodplain management regulations**.

MAP funding for floodplain management activities will be a reimbursement for costs incurred in the prior full calendar year. Reimbursement will be for **50% of eligible costs**.



Municipal Assistance Program (MAP) Grant

.Eligible Reimbursements Include:

Preparation and enactment of floodplain management regulations – Technical, legal, and clerical staff services, plus advertising, public hearing, and consultant costs.

General administration of floodplain management regulations – Staff and consultant costs for reviewing and processing building permit applications and for monitoring and inspecting floodplain development, plus mileage and other costs integral to eligible administrative activities.

Enforcement of floodplain management regulations Staff and consultant costs for restraining and prosecuting violations, defending against appeals, etc. pennsylvania




- Hazard mitigation is the effort to reduce loss of life and property by lessening the impact of disasters. In other words, hazard mitigation keeps natural hazards from becoming natural disasters. (FEMA 2020)
- Hazard mitigation is best accomplished when based on a comprehensive, long-term plan developed before a disaster strikes.





FEMA Grants





- FEMA Flood Mitigation Assistance Grant (FMA)*
- FEMA Building Resilient Infrastructure & Communities Non-Disaster Grant (BRIC)*
- FEMA Hazard Mitigation Grant Program Post-Disaster

FEMA Funding

- Generally FEMA will provide up to 75% of the Cost Share
- FEMA will pay up to 90% for impoverished communities
- BRIC Program 6% set-aside from previous years disaster total – Nationally Competitive
- BRIC State Set-Aside 2020 was \$600,000
- Flood Mitigation Annual from the NFIP Fund, Nationally Competitive; no state set-aside
- FMA pays 90% of eligible activities for RL and 100% for SRL mitigation of structures.














